Momentous Health Global LLC's Privacy policy is outlined by the information that follows. This privacy policy will outline how we collect, use, maintain and disclose information collected from Business Advocates ("BA") or Customers of the momentoushealthglobal.com website ("Site"). This privacy policy applies to the site and all products and services offered by Momentous Health Global LLC. Personal Identification Information

BA and customers have the option to update or correct their personal information at any time by going into their personalized back office under the "My Profile" section. As part of engaging in product purchasing the collection of personal identification information from Business Advocates and Customers in several ways may be needed. Including, but not limited to, when Business Advocates or Customers visit our site, register on the site, place an order, fill out a form, and in connection with other activities, services, features or resources we make them available on our site. BA's or Customers may be asked for, their legal name, email address, mailing address, phone number, credit card information and/or social security number. Personal information will be received only if the BA or Customer freely submits such personal information. The choice to submit the above personal information is solely under the discretion of the BA or Customer but without such information certain parts of product purchasing will not be available.

Web Browser Cookies

A short definition of a cookie is a small piece of information that is stored by your browser on your computer's hard drive. We use cookies for the sole purpose of uniquely identifying our BA's or Customers and securing their personal information. We may also use "cookies" to enhance the BA's or Customers experience. BA's or customers may choose to set their web browser to refuse cookies, or to alert them when cookies are being sent. If this is the case, please be aware that some parts of

the site may not function properly. Your privacy and security is not at risk when you accept a cookie from Momentous Health Global's site.

How to Use Collected Information

Momentous Health Global collects and uses BA's or Customers personal information for several reasons. It is possible that we use your email address, mailing address and/or phone number to provide quality customer support or to reach you regarding order status, product or fulfillment issues and other customer service related activities. We would also potentially use your personal information to send you information about new product offerings, promotions, marketing messages, market research, and enforcement of the Independent Enrollment agreements, and other items related to the policies and procedures. You have the ability at any time to "opt-out" of corporate email and therefor would not be contacted further unless you choose to opt back into the corporate email list. The only other email you will receive will be those that pertain to orders that you make. At that point you will receive emails regarding your product order.

How We Protect Your Information

The appropriate data collection measures are taken in the storage and processing practices. We are taking security measures to protect our partners against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on our site. We follow generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we receive it. Understanding the importance of keeping sensitive and private data exchange between the site and its users, we utilize a process that allows the site to exchange information over a SSL secured communication channel which is encrypted and protected with digital signatures. Our Site is also in compliance with PCI vulnerability standards in order to create as secure of an environment as possible for users.

Sharing Your Personal Information

Selling, trading, leading out or any form of handing off our Business Advocates personal information is prohibited. The information we collect about you is used to process orders, pay commissions and provide the services you need to work your business to the best of our abilities. We will not use or share your personal information provided to us online in ways unrelated to the ones described above without first letting you and giving you the opportunity opt out of unsolicited direct marketing material sent from us. We do everything possible to follow up with your request.
